October Jazz and Pom Class

Jazz + Pom will introduce age-appropriate jazz movement and pom combinations while building coordination, musicality, confidence and performance skills. A second class offers additional practice learning choreography and working together.

Both Tuesday classes	\$150 per month for Ballet + Hip-Hop and Jazz + Pom

How to enroll

Complete the Jazz + Pom enrollment request form. HCDC will add the class to your dancer's schedule and update your account beginning in October. The class requires at least six enrolled dancers.

Families enrolling in both Tuesday classes will be billed \$150 per month beginning in October. Families continuing with Ballet + Hip-Hop only will remain at their current tuition rate. We will notify families if minimum enrollment is not reached.

Fall program focus

Regular weekly classes are held on Mondays and Tuesdays. The previously listed Tap + Acro workshops and fall solo program are not included in this updated fall schedule. Showcase rehearsals and events are listed separately.

December Showcase

The Fall Showcase celebrates our dancers' progress and gives them an opportunity to share what they have learned. Participation is optional but highly encouraged. Please complete one participation form per dancer and select a payment option.

Showcase fee of \$200 per dancer

Includes group costume rental, Showcase T-shirt, awards and recognition, End-of-Season Celebration, production expenses, administrative expenses and Showcase operations. Group costumes must be returned to HCDC. Monthly tuition and showcase tickets are separate.

Payments begin in October. All Showcase Fees must be paid in full by December 1, 2026. The final December installment will be billed with prorated December tuition.

Tuition Billing and Registration

Charge	Due date
September–December tuition	1st of each month
Showcase Fee	According to the selected payment plan; paid in full by December 1

- An active card on file and Auto-Pay enrollment are required.
- Monthly tuition reserves the dancer's place and is not based on the number of class meetings in a particular month.
- Families are responsible for keeping payment and contact information current.
- Registration is first-come, first-served. Space is not guaranteed until registration and required payment are complete.

Late enrollment

New enrollments may be accepted while space remains. Dancers joining after showcase choreography begins may need to learn previously taught material with staff support. Showcase participation may be limited for dancers who enroll too late to prepare safely and successfully.

Refund policy

Tuition, Showcase Fees, registration fees and other program-related payments are non-refundable and non-transferable. Enrollment reserves a dancer's space, and staffing, scheduling and planning are based on enrollment commitments.

Attendance and missed classes

Consistent attendance is important for technique, choreography and showcase preparation. If a dancer must miss class, notify HCDC as soon as possible. Make-up classes are not guaranteed, and dancers remain responsible for missed material.

Dress Code Communication and Contact

Class	Required attire
Little Stars Ballet + Hip-Hop	Leotard, ballet dress or fitted dancewear; ballet shoes; clean sneakers for Hip-Hop.
Junior Trio	Dancewear or athletic attire; tap and jazz shoes or other shoes directed by the instructor.
Junior Hip-Hop	Comfortable dancewear or athletic attire; clean sneakers reserved for class.
Proposed Jazz + Pom	Class-specific footwear and pom information will be shared when enrollment is confirmed.

For every class

Hair must be secured away from the face. Every dancer should bring a labeled water bottle. Jewelry should be removed or kept to a minimum for safety.
